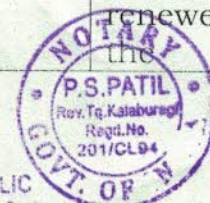

3. Without prior permission of the department no additional classes shall be opene.
4. The Books of accounts of the school shall be audited every years by the registered chartered accountants same shall be submitted to the department.
- 5.As per the RTE Act the number of sutdnets admission and attendance must be at the ratio of 30/25.
6. The fixed deposit amount shall be kept in the joint account and after the expiry of the period again it shall be re-deposited.
7. Subject to the conditions of KEB 1983 and grant in aid and the rules framed under sec. 36 of Karnataka Education Institutions (Primary and High schools) renewal of approval rules 1999.

4.The school shall run in the medium of instruction for which permission is granted and at the same place it shall be opened and for anyreason there is no provision to change the place. And to which the board of management to run the school permission is granted shall run at the same place in the same name and same board of management.

5.This Education society people with regard to education institute are subject to obey all the rules and regulations framed under Karnataka Education Act. 1983 (Karnataka Act. 1-96).

6.As per notification 175 PMC 95 dt; 7.9.1998 and 29.12.1998 this is permanently unaided one. And the management shall execute on the stamp paper of rs.10/- regarding consent duly typed and same shall be notarized before the Notary.

7. The Karnataka private Education institutes (the appointment of employees of primary and high school institutes and primary aided schools services and rules 1999 are to be followed.

8.All the books,science equipments, education kit, library books, shall be provided as per rules.


9. In each approved classes there shall be minimum 25% attendance shall be maintained.

10. Only the eligible and trained Teachers are to be appointed as per the rules.

11. Every year the medical examination of the student shall be conducted.

12.The fixed deposit amount shall be kept in the joint account and after the expiry of the period again it shall be re-deposited.

13.The class rooms, Library, and ply grounds school building, shall be provided within one year and it is intimated to have the area and class rooms.

14. With regard to opening of the school the admission of the students shall be intimated to the department within three months from the date of opening or within one month. In case the school is not opened or any of the conditions are not followed this order stands cancelled suo moto.

15.. A separate Toilet shall be provided to the Girl child. And pure drinking water also to be provided.

16. For preliminary approval the proposal shall be submitted to the deputy director as per the Govt. order dt; 30.9.2007 by availing information mentioned in schedule 3 check list. And within three months from the date of starting of school compulsorily the preliminary approval has to be given. In case if the approval is not obtained within prescribed this registration stands cancelled suo moto.

17. With regard to security and safety of the school building to protect from fire, tempest electric, electric accident etc; has to be ascertained within 100 yards of the school area regarding sale of tobacco productions is prohibited and the same shall be notified in front of the school.

18. If the school authority gives any wrong information, the department has reserved its powers to cancel the registration.

19 .As per the Govt. Notification No. ED369/PGC2014/ dt; 11.11.2014 and as per the circular of this office dt; 14.11.2014 all the conditions shall be followed.

20. As per the Govt. order No. ED.709/PGC/739/ dt; 7.3.2018 and as per the circular of this office dt; 26.3.2018 all the conditions shall be obeyed.
